

**Objectives and investment policy**

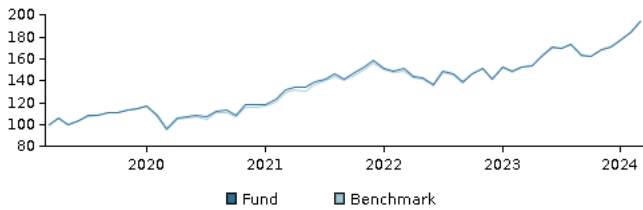
**Objectives**

The objective of this fund is to achieve a performance comparable to the benchmark, while contributing to a climate-resilient economy. The share class is accumulating.

**Investment policy**

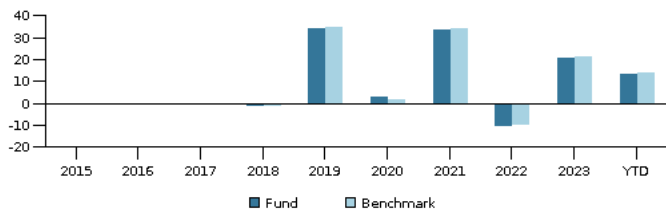
The fund seeks to track a low carbon benchmark. The fund is categorised as article 9 under SFDR and has a sustainable investment objective. In addition, the fund also promotes environmental and/or social characteristics through screening, exclusions, investment analysis and decision-making, as well as active ownership. The fund follows Danske Invest's responsible investment policy. In passively managing the fund's portfolio, the portfolio management team invests directly in a selection of equities included in the benchmark, using a multi-factor model designed to reduce trading costs and minimise tracking error. Tracking error is anticipated to be less than 1.00%, however it could be higher as the index may include stocks that are restricted from the fund's investment universe. Tracking error is a measure of the difference of returns between the fund and its benchmark. The fund may use derivatives for hedging and efficient portfolio management, as well as for investment purposes. A sample based physical model replicates the index which represents large and mid-cap equity performance across developed markets countries and is designed to exceed the minimum standards of the EU Paris-Aligned Benchmark. Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

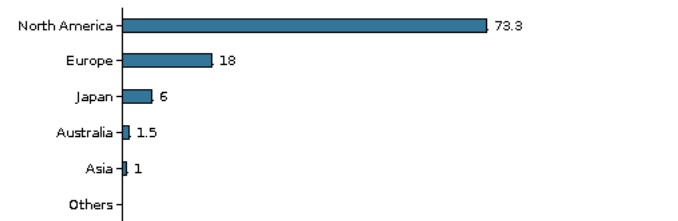

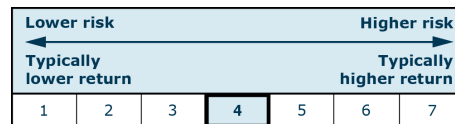
