### **Objectives and investment policy**

### Objectives

The objective of this fund is to achieve above-market performance and contribute positively to one or more UN Sustainable Development Goals. Dividends are normally distributed to investors each year.

### Investment policy

The fund invests mainly in European corporate bonds.

The fund is categorised as article 9 under SFDR and has a sustainable investment objective. In addition, the fund also promotes environmental and/or social characteristics through screening, exclusions, investment analysis and

decision-making, as well as active ownership. The fund follows Danske Invest's responsible investment policy.

The total modified duration, including cash, ranges from 0 to the benchmark duration plus 2 years.
